## **Senior/WIC Farmers Market Nutrition Program**

*RP Solutions' Transaction Processing Services (TPS) Platform is a complete Remittance Processing Solution that is used by many government agencies, insurance companies, utilities, non-profit organizations, lockbox organizations, and more. TPS currently supports S/FMNP programs across the country by providing full check clearing, tracking, and reporting services.*

### **S/FMNP Program Overview:**

The Farmers' Market Nutrition Program was designed to help eligible WIC participants exchange FMNP coupons/checks for fresh foods from farmers, farmers' markets or roadside stands approved by the state. The FMNP was established by Congress in 1992 to provide fresh fruits and vegetables to WIC participants and to expand the use and awareness of farmers' markets.

Similarly, the Senior Farmers' Market Nutrition Program was designed to provide low-income seniors with the same access to locally grown fresh fruits and vegetables through local Farmers' Markets. Currently, over 800,000 seniors receive SFMNP benefits each year.

### **Solution Overview:**

RP Solutions provides banking, processing, and reporting services for Government funded USDA S/FMNP Programs. This includes the WIC Farmers' Market Nutrition Program (FMNP) and the Senior Farmers' Market Nutrition Program (S/FMNP).
